1. Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- *The classes of information which we publish or intend to publish;*
- *The manner in which the information will be published; and*
- *Whether the information is available free of charge or on payment.*

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is either available for you on our website to download and print off or available in paper form.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

2. Aims and Objectives

Our vision is of a School where we all

'Inspire each other to aspire to the extraordinary'

We have committed ourselves to a number of specific Whole School objectives clustered in four sections which underpin all aspects of our work:

Academic Achievement

To meet and better yearly set targets for both GCSE and KS3 SATS and other types of educational accreditation.

Teaching and Learning

Language College status impacts on teaching and learning across the school, giving life to the concept of 'Internationalism'.

Each pupils 'learns to learn', to become an independent learner and so to ensure their continuous improvement in each subject.

Teaching & Learning strategies – including the use of ICT – are always employed to excite, challenge and stimulate all pupils as their learning needs are met.

The curriculum supports the learning needs of all pupils at the School, allowing each pupil to meet and exceed their potential.

Assessment processes inform planning and allow teachers and pupils to set and strive for higher standards of attainment.

Professional Development:

Every member of staff – through the entitlement of performance management – is supported in engaging in their individual professional development.

Staff are enabled to manage behaviour within and outside their own classroom, taking a consistent and continuous approach.

Sharing good practice through all meetings and through observation of teaching within the School and outside, raises confidence and competence and so morale.

The School as a Community:

Shene International School to become the first choice of secondary school for local primary school pupils with the majority of its pupils coming from Richmond Borough.

Pupils are proud of their School and this is shown through the way they wear their uniform and their appropriate behaviour when outside School.

The ethos of the School is one where pupils come to learn and is mutually supportive.

All pupils are encouraged to engage in at least one extra-curricular activity regularly.

All pupils to attend school regularly and be punctual.

The School Council is a high-profile, clearly recognised representative of pupil opinion and participates in School management and development.
